**HOURS & CONTACT:** 8 am – 4pm Monday to Saturday. Closed statutory holidays. All vehicles must report to the scale. To ensure “on-time” acceptance please be at the site by 3:30 pm. **LITTER:** Please do not litter on roadways and respect our [litter policy](#). Loose litter must be bagged. A fee is charged for loads containing loose litter or not adequately tarped. Loads with loose litter may be refused if wind is over 15 km/hr.

**WEATHER:** Please keep wind in mind for safe unloading. Visit [BVWaste.ca](http://BVWaste.ca) for [current wind](#) conditions.

**ACCEPTED MATERIALS:** The Francis Cooke Landfill is a “Class III” (inert, dry waste) facility. No liquids, food, kitchen garbage, or hazardous substances are accepted. See the opposite side of this sheet for a list of most common items that are not accepted. A minimum fine of \$100 applies to illegal materials left onsite. When in doubt please call 403-673-2708.

### ACCEPTED MATERIALS

The Francis Cooke Landfill is a "Class III" facility is approved to accept dry and inert waste only. No liquids, food, household garbage, or hazardous substances are accepted. Please call our scale at 403-673-2708 if you have any questions about where to take you unwanted materials or contact your municipality at the phone numbers listed below.

### TYPICAL MATERIALS THAT CANNOT BE ACCEPTED

- Agricultural wastes (fertilizers, cadavers, manure etc.).
- Batteries or transformers (lead, acids etc.).
- Chemically treated wood (creosote, PDF, CCA etc.).
- Contaminated materials or soils with >30% moisture.
- Fluorescent bulbs and tubes.
- Food wastes (anything biodegradable).
- Industrial waste not approved by Alberta Environment.
- Liquid waste of any kind.
- Paint or chemical wastes (aerosol cans, paint etc.).
- Pathogenic or herbicide containers (even if empty).
- Sewage sludge or bio-solids from waste water treatment.
- Small engines, such as lawn mowers, that have not been drained of all fluids.
- Waste oil, oil filters, antifreeze or related products.

If any of the above materials are left on site an Illegal Materials Fine of \$100 applies. The definition of Acceptable Dry and Inert Material may be periodically revised in order to ensure continued compliance with provincial regulations.

### RECYCLABLE MATERIALS

Please keep these materials separate and free of contamination so they can be unloaded separately for recycling and so that you can be charged the lowest rate while helping us extend the life of the Bow Valley's landfill. Check the list of fees for additional specifications that must be met to be eligible for lower recycling rates.

- Asphalt
- Asphalt Shingles
- Auto-wrecks (must be drained of all fluids with battery and tires removed)
- Broken Concrete, Bricks, Cinder Blocks
- Cardboard & Boxboard (small bin available for incidental amounts only)
- Construction Wood
- Cooling Appliances
- Drywall/Gypsum Board
- Electronics
- Mattresses and Box Springs
- Scrap Metal & Appliances
- Scrub & Brush or Stumps
- Soft Yard & Garden (leaves and grass)
- Tires
- Toilets (metal and plastic parts removed)
