## a) February Financial Update

The February financial reports were presented per the information provided in the agenda package. Year to date (2 month) ending February 28, 2023, represent 16.67% of annual linear budget. Total revenue is at 17.61% of the annual budget and 109.22% more than prior year. Total expenses are 9.55% of the annual budget and 10.34% more than prior year. Accounts receivable balance has increased by \$15,324.67 over prior month, which includes receivables of interest on overdue accounts. 5% of accounts receivable are older than 60 days. Interest on overdue balances over 90 days is being charged on a monthly basis.
